Safeguarding Children and Adults who are at risk is at the heart of all that we do.

Our vision is to protect, empower and advocate for every child, young person and adult who relies on our care, ensuring their fundamental right to live free from harm. Safeguarding is embedded in everything we do and underpins the work of all practitioners across the Organisation.

Safeguarding encompasses a wide range of actions taken by all of us to uphold the fundamental right of every child and adult to live free from harm.



Safeguarding Children and Adults

Safeguarding Children applies to all children up to the age of 18 years.

Safeguarding is defined by The Children Act 1989 as meaning that: "Agencies and organisations working with children and young people take all reasonable measures to ensure that risk of harm to individuals' welfare are minimised".

Where there are concerns that a child is suffering or likely to suffer significant harm, all agencies and organisations take appropriate actions to address those concerns, working to local policies and working in partnership with other local agencies.

Safeguarding Adults applies to a person 18 years and over.

Safeguarding adults is defined in the Care Act 2014 and means protecting a person's right to live in safety, free from abuse and neglect. The Care Act seeks:

To safeguard individuals in a way that supports them in making choices and having control in how they choose to live their lives.

To drive safeguarding practice that delivers meaningful outcomes and positive experiences for those we support.

To raise public awareness so that professionals, other staff and communities as a whole play their part in preventing, identifying and responding to abuse and neglect.

Promote and prioritise the safety of children and adults at risk.



Ensure that everyone understands their roles and responsibilities in respect of safeguarding.



Provide a transparent culture of learning and development.

Safeguarding in the Trust is focused on the places we serve through a borough-based approach.




We will foster a culture of partnership, actively listening to and learning from the lived experiences of children, adults at risk and their families.
